Pastor Matt Paul's Report

Be a Blessing!

"Now the LORD said to Abram, "Go from your country and your kindred and your father's house to the land that I will show you. I will make of



you a great nation, and I will bless you, and make your name great, so that you will be a blessing." (Genesis 12:1–2, NRSV)

Dear Friends in Christ,

Our stewardship theme for 2023 was *Be a Blessing*, which was based in part on God's covenant with Abram in Genesis 12. God promises to bless Abram and make him into a great nation. That blessing, however, was not solely for himself or his enrichment, but so that he and his descendants would be a blessing to the world. That is the approach I have always felt about the ministry of the church—that what we receive from God will only reach its full purpose when it is shared with others. Being a blessing is not so much a series of tasks, but a way of being.

The theme of being a blessing seemed to me quite appropriate for 2023. The world was still trying to get its footing after two years of pandemic-related disruptions—lockdowns, social-distancing, supply chain backlogs, and so on—so the idea of being a blessing seemed more fitting than the doing of blessings. In other words, we approached the year with a sense of seeing what would happen. What blessings would come our way that we could share with our community, and with the world?

Focusing on being a blessing requires patience and attentiveness to the movement of the Holy Spirit. One cannot make blessings happen; one must wait for them to come from the Lord. Once they are received, then they can be shared.

Before I continue, I want to tell you about a blessing God gives us in the church office from time to time: her name is JJ. JJ lives across the alley in the green rental house. She is a black kitty that makes her rounds in the neighborhood and loves to spend time around the church. On any given day you might find

her lying on the hood of a car in the parking lot, perched on the railing by the alley entrance, or running up to greet church visitors with a robust, "Meow!"

JJ is a blessing, and whenever Lauren and Cathi see her by the back door, they rush out to say hello

and give her some cat treats. JJ is a blessing to the neighborhood that her owners share. And she sure does bless us...simply by being JJ.

Just as JJ blesses us, I see in the people of First Presbyterian Church a blessing God has given to Port Angeles and to the world. Some more notable examples of the blessings that flow through FPCPA and into the world are in ministries like One Parish One Prisoner, the Creation Care Initiative, Celebrate the Children, and the Advent Event, just to name a few. But there are so many other ways God's blessings flow through our church.

One example is the way in which a number of volunteers have stepped forward to staff the nursery so the parents of young children can worship while their children are taught about Christ and Scripture. Their work is an act of servant hospitality that blesses young families and helps grow the community of Christ. Notice how this isn't about growing a particular church, but about sharing the love of Christ. Our nursery volunteers, along with our musicians, media team members, Sunday school teachers, elders, deacons, and the countless people who make FPCPA what it is, are all blessings. You are a blessing!

On a personal note, I want to thank you for allowing me to serve not only you but the greater Church of

Christ through my work with the Northwest Coast Presbytery. I am grateful for your allowing me to serve as co-moderator of the presbytery, which has allowed me to connect with churches and colleagues throughout the presbytery and to learn how our church can participate in what God is doing in our region. I am also grateful for the opportunity to serve on the Interagency Delegation to Alaska, to help heal the harm caused by the racist closing of Memorial Presbyterian Church in Juneau back in 1963. These experiences have been life-changing for me, and I hope to pass the blessings I've received forward to you and to others.

Another blessing we received in 2023 was the addition of Cathi Hughes to our office staff. Cathi has been a great fit for us and a gifted resource to our church. She extends the grace and hospitality of our church to all who come to the office or who call on the phone and never misses an opportunity to spoil JJ with kitty treats!

Office Manager's Report

The church office is rarely a quiet place, so I was glad that we found our new office assistant, Cathi Hughes, this past February to help run the shop.

What goes on all day in our cozy and beautiful church office? I can tell you that Cathi and I wear many hats! The most

obvious things we do are to answer phones and emails and create the Sunday bulletin and slides. But that's not all! Here are some of our varied roles:

We Are Reporters and Archivists

Creating publications is our "press" hat, you might say. We work for the ministries and committees of the church to publicize your activities and events in as many formats as possible: weekly and monthly newsletters, the website, bulletin inserts, and slides for Minute for Ministry presentations.

We compile the working documents of the church, like session packets, policies and procedures, staff timesheets, and building maintenance records. Collecting the committees' meeting minutes, the treasurer's financial reports, and helping craft the session meeting's agenda are all a part of the monthly session packet. At the end of each year, the Annual Report is compiled and published as well as the year's approved session and special meetings minutes for our presbytery's records. We also enter baptisms, new members, and other information into the archival church book of record that is kept in the office.

We Are Schedulers

Though we are not responsible for the church building per se, we handle much of the scheduling of maintenance and inspections on items like the elevator, fire alarm system, and kitchen. This year we came to the end of the serviceable life of the office copier, so I have been working with Pacific Office Equipment for the past several months to find the

church a new machine. It was delivered January 10, 2024, and we hope it will be easier to use and will produce high quality copies.

We Are IT Geeks

Speaking of maintenance, the digital age was supposed to make everything easier, right? Every digital service requires that the office "Geek Squad" learn to use it, maintain it, and teach others to use it. Some of you are familiar with a few of these items: "Proclaim" software to create and run worship service slides, the online *Instant Church* directory, and—we can't forget—"Zoom" for meetings.

We maintain "Proclaim," the church website, our YouTube channel, a Dropbox digital storage system, Google Drive, and copyright licensing subscriptions. I update the balcony, office, and Sunday school computers and keep software on my cell phone to ensure our security cameras and wireless network are up and working. Anytime someone needs a new email address, a password reset, or a place to store digital files, I assist them by working through the Administrator module of Google Drive.

And We Are Friendly Faces

We enjoy our work in our comfortable office environment, and we hope you always find us to be helpful and happy to serve. That's what kind of church you are, and we want to reflect that back to you.

Deacons' Report



Deacons serve our congregation by providing care, service, and support for our church family. Each deacon is assigned a "flock." We strive to stay in touch with our flocks in person and through cards, phone calls, and visits to homebound members. We

meet the third Tuesday of every month to conduct business and to pray together.

On communion Sundays, Carol Foss, Bobbie Buckley, and Dona Hair oversee the preparation of the elements. Rainy Birch bakes the communion bread and Cindy Gallinger arranges home communion visits. A team of two deacons visits homebound members to share the sacrament of Holy Communion. The teams visit one or two homes on the first Sunday of every month. A Parkview Villa communion service is included in these visits since a number of our homebound congregants live in that community.

Bobbie Buckley, Dona Hair and Pat Davies work together on the Helping Hands Committee which oversees memorial receptions, helps arrange meals for families in need and other needs of the church family. Helping Hands coordinates congregational volunteers to serve in many aspects of ministry. All members of the church family are welcome and encouraged to serve in the following ministries:

Session Committees and Ministries Reports

Building, Grounds, and Properties

Many of the maintenance matters of the church are well taken care of by the men on the committee. We are fortunate to have skilled and willing people. New volunteers are most welcome.

It is also a gift to all that many individuals come when we have a day for extra property care. This is when the yard receives raking, pruning, and tasks that keep the grounds attractive. Year around Melanie DeBiddle and Rainy Birch give their time to tend the planting beds.

The balcony extension was completed in early 2023, a big job that serves well the needs of the dedicated tech team that works up there each week. And it again allows for many people to use the balcony. Along with Hoch Construction, Ross Canning, Chris Duff, Michael Rivers, and Paul Stutesman made this rebuild possible with their construction skills and good coordination.

Changing furnaces from propane to electric is a continuing multi-year project. As this is done, consideration for the budget, the environment, and the cost of propane versus electricity are all studied. Adding heat exchangers to some of the electric furnaces could save us operational costs in the future. It is natural that these furnaces need services and adjustments at times.

The elevator requires annual required service. Periodically, new Labor & Industries safety codes require expensive changes or special inspections.

With the help of Randy Schuchardt, several motion sensitive cameras were installed in selected places in the church. These serve us well at night when no one is usually in the building. They record information well, so there is no question about any activity. The ones by exterior doors are also helpful when

employees are alone in the building and hear unexpected activity.

Lauren Corder and Rosalie work together on decisions about building use by groups who wish to use our building. We take into consideration the established church policy and mission considerations for the groups.

The second story single pane windows are old. Some have severely rotted frames. To help conserve heat, Paul keeps track of when the rooms are used. He sets the thermostats to warm the rooms when necessary and then shuts them off. There are thermal shades on the big windows to aid in heat retention. Because of the condition of the framing, a contract was accepted to change the windows along the south side first. When our turn came for the work, the weather was changing, so outside preparations for painting around the windows and the fascia and lower areas on the south side of the building had to be delayed. It will proceed when the weather is suitable. When our budget allows, the north windows will be replaced along with necessary improvements around them. Also, the flat roof will be cleaned.

With the annual Fire Alarm Panel inspection, we learned that several emergency exit lights were no longer functioning as they should. All exit lights have been replaced with LED systems and automatic lights installed in places necessary to help people exit when it is dark.

A number of special maintenance projects and upgrades are in the planning stage for 2024 as we strive to care for the building where we worship, study, fellowship, and work to carry out our mission. Our rental houses receive needed maintenance throughout the year. When necessary, contractors are hired, but often the work is done by committee members. Gutters of both houses were cleaned by contract. The 7th Street house has a new deck thanks to Doug Erickson and other committee members. The small house on Oak Street finally got the needed bathroom remodel by contract.


Christian Formation

Adult Formation

Adult Sunday School is offered at 9:45 am on Sundays in the upstairs classroom. Several different options are explored, from contemporary issues that our church needs to confront to studying the books of the Bible. - Wayne Brown led a study on poverty and how we can help.
- The last class of the year was a study on Hebrews that was led by Todd Haworth.

Children, Youth, and Families

A variety of curricula are being used, along with Bible stories, songs, and crafts. (Faith Alive and Super Simple Bible Lessons and Ready to-Use Bible Activities). There are up to six children attending nursery during the 8:30 am service. Seven adult church members are volunteering their time to lead the class.

Youth are meeting once a month with Becca Paul and Michael Rivers for community activities and Christian education (game nights, pizza dinners, gingerbread house competitions, and ice skating, along with Biblical discussions guided by our Christian leaders). Advent booklets were distributed to all children and families.






There are nine lessons and in June we have a recap of what we have learned, along with a potluck lunch.

One Parish One Prisoner (OPOP)



The OPOP Team

A lot of change can happen in a year. The result of change, especially when one is not in charge of it, can lead to a whole range of emotions and self-evaluation. This is certainly true in the case of FPCPA's OPOP team.

The year started with excitement and high expectations with the release of Jordan from the Washington Corrections Center for Women in February 2023. Several of the team members shared her first non-prison meal, took her shopping, facilitated her reunion with her son Noah, and got them established in their new digs in an Oxford House (OH) in Sequim. What followed for Jordan was a whirlwind of mandatory meetings with mental health, recovery programs, and DOC. She was selected by the regional Oxford House programs to become the liaison between OH and persons releasing from prison who wanted to live in sober housing within Clallam County. Interspersed with all the requirements of her release, Jordan was also looking for work and taking online classes at Peninsula College. So, in a very few months, Jordan went from a completely structured environment to one where self-management was essential. At the same time, Noah was experiencing a terrific amount of change too, from getting acquainted with his mom, to a new home, different peers, and a different school.

Throughout this time, the OPOP team was assisting with transportation, medical support, and job assistance. FPCPA rolled out the welcome mat and raised funds for transition expenses, while various members took Jordan to lunch and shared their time and expertise with her. Who can forget Jordan's baptism service and the fun we shared at the *Celebrate the Children* event?

For reasons not fully understood, Jordan decided to move back to the Tri-Cities. She did the responsible thing by getting approval from DOC and was admitted to a Richland Oxford House. On July 1, the OPOP team facilitated her move. She was excited to see her mom after two years' absence, and she was looking forward to Noah being able to re-connect with his cousins and other relatives. She expressed at the time that she believed she knew what boundaries she would have to maintain to be able to sustain herself back in her old environment. She also felt she would have more options for getting a paid internship through one of the programs she was involved in while incarcerated.

Being away, communication between Jordan and the OPOP team reduced significantly in volume but what information the team was able to get was positive, to include that Noah was enjoying school, Jordan was going to start a paid internship program, and she had found an affordable apartment. But by mid-September, the team found out she had relapsed and had missed a required DOC appointment. SILENCE.

The silence was excruciating for the OPOP Team. We have felt it all: disbelief, anger, sadness, fear for Jordan's safety, anxiety. We have had to face some of our own preconceived notions regarding addictions and the possible limits to how far we will go to be instruments in extending God's grace to her.

Then in December two of the team received a short communication from Jordan. We invite you to join with us in prayer on how best to keep this glimmer of hope alive, to keep Jordan safe and, if we are fortunate enough, to be able to continue the journey with her.

We also invite you to consider becoming part of Underground Ministries financial support. Information about Underground Ministries and donation cards are beneath the OPOP bulletin board in the hallway as you exit the fellowship hall to the parking lot.

Service to Port Angeles Schools

The Answer for Youth (TAFY)



The Answer for Youth is a drop-in center that serves homeless and atrisk teens and disadvantaged young adults up to age 35. We have been open for 15 years now. TAFY was

founded on Christian principles, and the founders frequently find opportunities to share their faith with the clients. We have a very personal and interactive ministry. Since the time we started, we have gone from five clients a night to as many as 60 at times. We are open four days a week (Monday, Wednesday, Friday, and Saturday) from 3-7 pm. We serve hot food, provide showers, and have a washer and dryer available for use. We have a used clothes closet and provide toiletries and minor first aid products. We offer help with some medical expenses and prescriptions, including eyeglasses. We assist with items that help them cope with living on the streets, including tents, sleeping bags, propane, hand warmers, and tarps.

TAFY runs a greenhouse from 10 am - 2 pm. Some of the clients help with watering and weeding and cultivating the vegetable garden where we grow food for our consumption. The proceeds from the greenhouse help subsidize TAFY's expenses.

The Presbyterian Church has helped TAFY in many ways. The church provides a hot meal every other month on the first Saturday of the month. Several people provide a portion of the meal, and it is always the best meal brought to TAFY. The clients are always excited when they know that the Presbyterians are bringing the food, as they know it will be great. Marcia Logan has helped coordinate the Saturday night meals, which is greatly appreciated. The church also has given some money to TAFY every year, and we are very grateful. Also, the Ladies Bible Study group has, for years now, put together 30 Christmas gift bags for our clients. It has evolved each year, and I believe this year was the best year ever! Each bag included knit hats, socks, a brush and comb, flashlights, lotion, gloves, a gift card to Walmart, and so much more. It is fun to see our clients' delighted faces when they look into the bags. This year the bags were reusable bags that were sturdier. I think that was a great idea. Sometimes this is all they get for Christmas. It is so appreciated; I can't thank the Bible study group enough.

I know that the church regularly prays for TAFY, which is greatly needed. People also donate clothes, blankets, towels, and sheets. There is a collection box at church right next to the elevator. In addition, this year, the knitters of the church have started a project of knitting scarves for the clients.

How can you help? TAFY always needs empty plastic containers—like cottage cheese, yogurt, or sour

cream. The clients often ask for food to go, and we give them some food in those containers. If you have some, you can bring them to the TAFY collection basket at church. Also, we need used clothes and blankets. If anyone gets the sudden urge to bake a dessert or make a casserole, we would be happy to take those items!

I always appreciate your prayers and support for this vulnerable population. Thank you from the bottom of my heart for your help with this local mission.

Christmas Gift Cards

For the past four years the church's annual Christmas Basket Project has provided grocery gift cards rather than filling boxes of donated food and household items and delivering them to recipients' homes. This year the congregation was asked to donate money to purchase those grocery gift cards. The response was overwhelming! Your 2023 gifts totaled \$8,233! Thank you.

Your generous donations allowed each of the five grade schools in Port Angeles plus Stevens Middle School to select six of their students' families to receive the gift cards. In addition, gift cards were provided to 14 households suggested by church members. This totaled 50 households that received Walmart gift cards. The cards ranged in value from \$100 to \$200 each, based on the family's size. The gift cards were "Restricted Use": They could not be used to purchase alcohol, tobacco, or lottery tickets. The amounts given to each family have increased over previous years due to the rising cost of food and other necessities. There were more "extralarge" families than in past years, including one family with ten members and another with 12. The cards provided assistance to more than 80 adults and at least 120 children.

Each school's gift cards were enclosed in Christmas cards and delivered to the school office by members of the Community Life Committee the week before the schools' winter break began. Parents picked their cards up from their school office. Cards for recipients suggested by church members picked their cards up at the church office. Community Life members delivered the cards to those who were unable to pick them up.

Again, thank you for your generous donations and help that made this a very successful project. The schools and recipient families were extremely grateful for these gifts. More than one parent said they would not have had a Christmas without your gifts.

Financial Reports

Stewardship

The Stewardship Committee is responsible for all financial budgeting and transactions, excepting those concerned with the property and grounds. It is responsible, in unity with the pastor and session, to promote stewardship of tithes and offerings through an annual campaign and throughout the year.

The committee currently consists of seven members: Rainy Birch (Treasurer), Susan Fisher, lantha Frazer (Finance Clerk), Jason Mayo, Tom McCulloch (Elder and Financial Secretary), Bob Pappas (Elder and Moderator), and Pastor Matt Paul. If anyone is interested in joining us, please let us know. Monthly Stewardship meetings involve reviewing the monthly financial statements to monitor financial health, manage investments, and ensure we remain on target with the budget and financial stability.

We began 2023 concerned by a projection of a budget shortfall of just under \$48,000, even after applying our projected rental income and a contribution from our investments. We end the year grateful that with a combination of (1) a continuation of our congregation's long history of steadfast and generous support bringing receipts in above projections, and (2) our committee's perpetual vigilance in being good stewards of our resources by keeping our expenses below projection, it looks like we will end 2023 in the black, with receipts (including rental income and investment contributions) exceeding our operating expenditures by a bit.



This year's Stewardship Campaign theme was Cultivate Joy. The result was 66 pledges from members and friends for a total of \$283,540.

Twenty-eight of the pledges were increases from 2023, and three were new. Both the number of pledges and the dollar amount pledged are down from last year, when we had 76 pledges for \$299,972. We are hopeful that the shortfall will be covered by our growing non-pledged contributions.

The budget for 2024 includes higher revenue and lower expenses. As a result, we are projecting a smaller deficit (\$34,767, down from \$47,999). However, we are hopeful that, as has happened so many times in the past, higher than projected income and lower than projected expenditures will bring us closer to being in balance by the end of the year. Again this year, the projections include our projected income and expenses from the rental properties the church owns and a percentage return on our sizeable investment account.

The financial health of our church remains extremely strong and was bolstered again this year by two particularly noteworthy gifts:

The first is an anonymous gift of \$100,000, to be added to our investments and used to help fund the ongoing mission of our church. This gift and a similar gift last year have been truly transformational. They have allowed us to increase our investment reserves and make an annual contribution from those investments to our current operating budget, both while funding a multi-year capital projects budget to maintain our aging building.

The second is a \$32,666 anonymous bequest set aside, per donor request, to be used for building-related capital expenses---a welcome contribution to our 2024 projected capital expenses of \$43,475. We are truly blessed by these donors.

At the committee's suggestion, session approved a move of our investments from D.A. Davidson to the Presbyterian Foundation's New Covenant Trust Company. Though pleased with our local D.A. Davidson personnel and their good service, we thought the investment management function for our socially responsible investment strategy, which was not handled locally, could be more effectively carried out with New Covenant Trust Company. The two companies helped make the transition a smooth one.

Session also approved the processing of an application with the Internal Revenue Service for tax credit funds under the Economic Recovery law. The application was submitted with the assistance of an accounting firm and a lot of data collection by Susan Fisher, but it is still not clear when it might be processed. It appears we should qualify for a significant refundable tax credit, but we are not counting our chickens just yet.

The Stewardship Committee remains very grateful for the support that you all provide to help make all that our church does possible.

Contribution Statements and Other IRS Related Documents: The annual contribution statements are sent out via email if we have your email address recorded in our system sometime around the end of January. If you require a mailed contribution

statement, please call the office or myself and I will mail you the contribution statement. If you require a document from me that lets the IRS know that your contribution is from your particular tax-related investments, I can do that. If you have any questions about your financial statement or need a copy of your statement at any time of the year, please call me or email me at financial.secretary@fpcpa.org. I am more than happy to resolve your issues and can resolve most of the problems if you ask me.
